## Editorial notes

1. The date of the slab is given as the date of death of the person or last person commemorated; dates are given in Old Style.
2. Dimensions are given width first, length second; where it is possible to measure, the thickness is given last.
3. Grid references are given for all churches.
4. All letters and decoration are embossed unless stated; 'flush' and 'recessed' relate to the general surface of the slab; 'planklines' indicates the vertical lines formed by planks used to create a flat casting bed.

There are 121 known pre-Industrial revolution iron graveslabs in England and Wales. Of these, 92 (76%) have their origin in the Weald of south-east England, and 29 (24%) are to be found elsewhere.

## EARLY IRON GRAVESLABS CAST IN THE WEALD

### ESSEX

#### RIVENHALL TL/8316<sup>1</sup>

1. 1706/7, THOMAS WESTERN, 90 x 210cm

Roman capitals of 7cm and 4.5cm; moulded edge; full achievement: Western - Sable, on a chevron between two crescents in chief and a trefoil slipped in base or, a crescent for cadency; inscription centred. From the casting it is evident that the wooden pattern for this memorial was prepared in advance of Thomas Western's death. The numerals for his age and the text, ☼OBIT☼, on the penultimate line, and the date of his death (with the exception of the initial word, THE) on the bottom line, were inserted as separate blocks into spaces left for the purpose before casting.<sup>2</sup>

This Thomas Western, known as 'The Great Ironmonger' and controller of seven ironworks in the Weald, was the father of Martha, wife of Peter Gott, whose slab is at Streat (No. 2). Martha and Peter's children recorded on the slab at Streat all bear the same names as Thomas Western's children. The slab is the furthest of any from an ironworking area.

## KENT

### CHIDDINGSTONE TQ/5045

1. 1601, RICHARD STREATFEILDE, middle aisle against south pews; 53 x 153cm.

Inscription in recessed panel 49 x 22cm with 1.9cm flush letters; an extension has been made for the final '40' below the panel. High beaded rim 2cm wide round slab.

This is the first of many memorials to the Streatfeild family which continue until 1966. On the south wall is a monument to Henry Streatfeild who died 2 March 1709, aged 71 "and is buried under the Iron plate in the Middle Ile of this church". The Latin motto, *Vivit Post Funera Virtus*, means 'virtue outlives death'. The probate inventory accompanying Richard Streatfeild's will includes Pilbeam's Forge at Ashurst and the furnace at Chiddingstone where this graveslab is likely to have been cast.<sup>3</sup>

2. 1714/15, THOMAS BASET, south aisle; 88 x 183cm.

5cm *incised* letters of 1cm wide lines. L of Michael reversed; each A has top bar; each I has cross bar. Mud crazing and planklines. Thomas Basset was the brother-in-law of Ann Basset (no.3) and in his will left bequests to her three daughters.<sup>4</sup>

3. 1714/15, ANN BASSET *née* CRONCK, south aisle; 88 x 183cm.

Slab similar to no.2 to THOMAS BASET. 5cm *incised* letters with lines 1cm wide. One G reversed; N reversed; each I with cross bar; each A with top bar; one A with cross bar omitted. Mud crazing and planklines. Ann Basset's husband was the brother of Thomas Basset (no. 2).

### COWDEN TQ/4640

1. 1622, JOHN BOTTINGE, nave, partly under front north pew; 60.5cm wide, lower 80cm exposed.

Inscription in recessed panel 38cm wide with rounded corners; 5cm flush letters; central crossbar to each I. Blister holes to lower slab. There was a 'clearing of the church throughout' in 1884 followed by the provision of new pews which left the slab partially covered. The inscription has been completed from an

earlier transcription by John Thorpe.<sup>5</sup>

2. 1726, RICHARD STILL, *churchyard* northeast of chancel; 79 x 183cm.

Low brick altar tomb covered by thick cast-iron slab having overhanging ovolo moulded edges.

3. 1730 MARY STILL, *churchyard* northeast of chancel; 79 x 183cm.

Low brick altar tomb covered by thick cast-iron slab having overhanging ovolo moulded edges.

Adjacent tombs. Finely formed and cast letters 0.7cm proud; large capitals 4.7cm, small capitals 3.3, centred lines. To allow for the hollow form of these two graveslabs they would have been cast in a closed, loam mould rather than in an open, sand mould, making them unique among the graveslabs of the Weald.

The Stills were of Waystrode, in Cowden.

### **EAST PECKHAM St. Michael's TQ/6652<sup>6</sup>**

1. n.d., WILLIAM BANSOR, nave, 64.5 cm x 117.3 cm. Incised gothic inscription on *brass plate*, 15.4 x 7.1 cm.

**[...]lyth Williamus/Bansor [... ... ]/[... ... ]**

Plain uneven slab with stepped cross (23 x 85.6 cm), with inscription plate below, indecipherable apart from the name.

The cross is formed of five strips/bars, all c.2-3 cm wide, making up the three steps, the main vertical and horizontal elements. The horizontal cross bar was impressed after the others. This iron memorial may have replaced an earlier, memorial brass, perhaps removed during the Reformation, with only the inscription being retained. William Bansor, was noted as incumbent in the parish before 1420;<sup>7</sup> the use of the cross is consistent with him being in holy orders.

### **FOOTS CRAY TQ/4771<sup>8</sup>**

1. 1665, MARTIN MANNING and BARBARA MANNING, *churchyard*, 1 metre south of chancel; 65-68 cm wide x 181 cm long x 3 cm thick. Loose, formerly on brick plinth.

*Incised* 3 cm letters in straight, well-spaced lines. Each line starts c.5 cm from the left edge of the plate but continues almost to opposite edge. Above the inscription is a pair of incised, crossed bones, each bone

c.28 cm long. The slab lies face down adjacent to its former plinth and had to be turned over to read the inscription. Although most of the lettering is just decipherable, an earlier, published notice of this slab has been used to confirm the inscription.

### **HORSMONDEN TQ/7038**

1. 1644, MARTHA BROWNE *née* TYLDEN, base of chancel step, head to south; 59 x 159cm. Incised inscription on *brass plate*, 38 x 17cm.

**VNDER THIS PLATE LIES BVRIED/  
Y<sup>E</sup> BODY OF MARTHA BROWNE/  
THE BELOVED WIFE OF IOHN/  
BROWNE ESQ SHE DECEASED/  
IULY Y<sup>E</sup> 28.1644.**

1.6cm engraved Roman capitals. Plain edged slab. John Browne (died 1651), of Shirrenden, worked the furnace on the border between Brenchley and Horsmonden parishes, 3km north of the church. He made guns for James I, Charles I, the Commonwealth, and the United Provinces (Netherlands).

## SURREY

### BERMONDSEY (London) St. Mary Magdalen, TQ/3379

1. 1718, WILLIAM and ELIZABETH MERCER, north aisle, head to north; 89 x 177cm.

Fine thin 5cm letters with serifs; well spaced words filling each line. Raised beaded rim.

### CROWHURST TQ/3947

1. 1591/2, ANNE FORSTER (Foster) *née* GAINSFORD, under altar; 54 x 137cm.

**HER:LIETH:ANE:FORST/R:DAVGHTER:AND:/  
HEYR:TO:THOMAS:/GAYNSFORD:ESQUIER/

Inscription on a block 64 x 41.5cm placed sideways at top. Inscription cast from a single carved wooden pattern, which subsequent castings reveal was formed of two boards battened together; each letter is different: S and Y reversed, F inverted. Below on the slab to right of inscription is a 36cm relief figure in a closed knotted shroud representing Anne. On either side are shields on oblong blocks (12.5 x 17cm) showing her children: on her right two sons semi-kneeling with the letters W and R above; on her left the daughters kneeling (only the front two are clear, the other three are faintly shown behind).<sup>9</sup> In the lower corners are heraldic shields, one showing a chevron between three running hounds for Gainsford. The other is of Foster (of Little Baddow, Essex) quartering Tendring and Gainsford.<sup>10</sup> There are rope edges on all four sides around a border of large bunches of grapes. The only slab with effigial representation.

Anne Gainsford (b. c1539) married William Foster, whose mother had been Margaret Tendring, in about 1560 and became her late father's heir on the death of her brother, John, in 1559. Her eldest son, William, was knighted in 1603.

The inscription block was subsequently used to decorate firebacks.<sup>11</sup> Examples, all different to a greater or lesser extent, can be seen (inappropriately) in the churches at Ardingly and East Grinstead, in Anne of Cleves Museum at Lewes (four examples) and in The Six Bells public house at Billingshurst; at least four others are known in private hands. The chancel was restored in 1886.

## EAST SUSSEX

### BRIGHTLING TQ/6820

Six similar upright headslabs cast from same mould; 57.5 x 73cm, plus 17cm above for pediment, plus 36cm below to be sunk into ground, x 3cm thick.

1. 1744, NICHOLAS RUSEL, *churchyard* northeast of chancel.

**HERE Lyeth/the Body of/NICHOLAS RUSEL/  
Who dyed April y<sup>e</sup>/ ...th 1744 Aged 57**

*Incised* inscription, lines curved upwards.

2. 1757, ELIZABETH PIPER, *churchyard*, northwest of tower.

**In Memory of/ELIZ PIPER/Wife of JESSE  
PIPER/of this parish Who/departed this life/ ... 175../ .**

*Incised* inscription, lines curved upwards.

Elizabeth Piper was housekeeper to John Fuller, father and son, of Rose Hill (now Brightling Park), who died in 1745 and 1755 respectively.

3. 17??, [...] PIPER

**In Memory of/ ... PIPER/// ... this Parish .../Who departed this life/...**

*Incised* inscription, lines curved upwards.

4. Headslab adjacent to No.2; indecipherable *incised* inscription.

5. & 6. Two slabs in south porch upright against west wall; no visible inscription, apparently unused.

All six slabs with main face having a border of festoons tumbling from eye sockets of skulls at top corners; cornice with egg and dart moulding; shaped pediment with foliage, *patera*, and scrolls bearing embossed letters *NOVOMVS MORIAR*. The inscriptions were *incised*; parts of only two inscriptions remain but are rapidly becoming indecipherable.

The furnace at Socknersh was in the parish and the church contains many marble memorials to the Collins family who owned it. There are no iron slabs inside.

### BURWASH TQ/6724

1. c.1537, JOHN COLLINS, mural, south aisle chapel; 47.5 and 46.5 x 168 and 167.5cm.

**ORATE P ANNEMA/JHONE COLINE**

(*orate pro anima* - pray for the soul of) 2.5cm Lombardic letters.

The use of lombardics is an anachronism; they were in use in the 13th and 14th centuries. Because of the use of this style of lettering early writers on iron casting in the Weald placed the making of this slab in this early period, this incorrect ascription being perpetuated by later writers. However, as iron casting was not introduced into England until c.1490, this slab cannot date from before then.

A very narrow slab with plain borderless edges. Above inscription is a floriated cross 30 x 7.5cm on a tall oblong base 5.7 x 11cm. The earliest English cast iron graveslab.

John Collins, who worked Burwash Forge, and Socknersh Furnace in Brightling parish, died in 1537.



## CHAILEY TQ/3919<sup>12</sup>

1. 1762, RICHARD PORTER, under tower; 90.5 x 182cm.

**Here lieth the Body/of Richard Porter AM./  
Who was eight Years/Rector of this Parish./  
He Died the third day/of February Anno Domini/  
1762/Aged 46 Years.**

Plain, borderless slab; very even Roman letters in centred lines 26cm, from top edge and 94cm from bottom edge; caps 4.5 - 4.9cm; lower case 3 - 3.5cm.

Noted by Horsfield as being in the aisle.<sup>13</sup> Richard Porter was educated at Jesus College, Cambridge, and was Rector of East Hoathly from 1741, resigning the living in 1752 in favour of his brother, Thomas, to become Vicar of Mayfield. In addition he became Rector of Chailey the following year, there succeeding his uncle, also Richard. The graveslab of another member of the Porter family - Frances, *née* Colpepyr, the wife of another Thomas Porter - is in Wadhurst church. Despite the Wadhurst slab being older by 45 years, the similarity of the size and style of the lettering with the example in Chailey suggests that both graveslabs may have come from the same source.

## CROWHURST TQ/7512

1. No date, chancel, under boards of organ platform; 80 x 204 x 2.5cm. Plain slab, only about 15cm protrudes from under the organ platform installed 1930. When the boards were lifted in May 1983, the slab was found to be totally plain. The church was restored in 1856 by S. Teulon.

## FRANT TQ/5939<sup>14</sup>

1. 1631/2, S F [SYBIL FOWLE *formerly* GRAYE], central aisle west; 65 x 189.5 x 2cm.

**S F/1631**

No inscription; five shields 18 x 14cm each showing the Fowle crest (out of a coronet an arm holding a battleaxe) above the initials SF and the date 1631 below, all within a rectangle. Sybil, widow of Thomas Graye of Horsted Keynes, was the third wife of William Fowle of Riverhall, whom he married at Frant on 12 Jun 1614. She was buried on 22 Jan 1631/2.

2. Undated, c.1606, E F [ELIZABETH FOWLE *née* PANKHURST], centre aisle west; c. 66.5 x 189cm.

**E F**

Four shields, one in each corner, each on a square block with the Fowle arms (gules, a leopard passant between three roses or), and two shields placed down the central axis each bearing a square with the Fowle crest (out of a coronet an arm holding a battleaxe) above the letters EF. Elizabeth, *née* Pankhurst, was the first wife of William Fowle, whom he married at Mayfield on 8 Feb 1590/1. She was buried on 26 Oct 1606. The arrangement is the same as on the slab in Wadhurst church (No. 3), and the armorial shield is from the same block used there and on a number of firebacks.<sup>15</sup>

3. Undated, c.1612, M F [MARY FOWLE *formerly* WHITTON *née* FINCH], centre aisle west; 67 x 188cm.

**M F**

A large shield top centre shows the Fowle arms impaling quartered arms: 1st and 4th, Whitton (argent, five plates on a chevron sable) differenced with a mullet, a mark of cadency (Thomas Whitton, Mary's first husband was a third son); 2nd, Gaynsford (gules, a lion passant guardant argent between three

buckles or); 3rd, unidentified (on a fess between six crosses crosslet, three mullets).<sup>16</sup> Below the shield are the letters MF. Mary, formerly Whitton, of Lamberhurst, was the second wife of William Fowle, whom he married at Frant on 13 Jan 1606/7. She was buried on 31 Aug 1612.

All three Frant slabs lie hidden under a carpet in the nave beneath the west gallery. The church was rebuilt from 1819 to 1822: the piers supporting the west gallery are of cast iron. The Fowle family held the Riverhall Furnace on the boundary of Frant with Wadhurst.

In Maidstone Museum is a plain slab with two shields of the Fowle family identical to those on a slab in Frant (No. 2) and Wadhurst (No. 3).<sup>17</sup> At the lower end of the slab is a small rectangular stamp showing the crest of the Fowle family beneath which are initials which appear to be NF. The stamp is similar, but not identical, to the rectangular stamps on the slab in Frant (No. 2) and Wadhurst (No. 3). From its dimensions, this graveslab could have been for a child, or probably a pair of children. It is not known from whence it came to the museum.

### HARTFIELD TQ/4735

1. 1702, JOHN MILLS, south arcade in front of easternmost pier; 53.5 x 150.5cm.

**Heare ly<sup>e</sup>s the body of/Muster John Milles [...]/of Cotchford in Hartfield/Suxsix he died 25 [...]  
of/October: [...] a domany 1702**

*Incised* letters; plain borderless slab. Poorly formed uneven lower case letters. Parts of the inscription are now difficult to decipher. The church was restored in 1867.

### LAUGHTON TQ/5012<sup>18</sup>

1. 1689, L B (LUCY BENGE), mural, under tower; 45.6 x 87 x 2.5cm.

**L-B/1689/L-B**

Individual 8.5cm Roman upper case letters; plain borderless slab. Lettering is 18.5cm from top and 34.5cm from bottom.

There is a close similarity between this slab and the one commemorating Dorothy Alchin (Wadhurst no. 26), who was a cousin of Lucy Benge's father, the ironmaster William Benge.

2. 1691, ANN BENGE, mural, under tower; 42 x 101 x 1cm.

**ANN/BENG/1691**

7.5cm Roman upper case letters on a block, A with top bar, and middle horizontal of E sloping upwards. Plain borderless slab with inscription 49.5cm from top and 27.5cm from bottom.

Lucy and Ann were the daughters of William and Dinah Benge of Wadhurst. Their mother, born Chauntler, from Laughton, was sister-in-law to John Barham of Shoemiths, Wadhurst; their father cast shot for the government from 1686 and, ten years later, built Gloucester Furnace at Lamberhurst.

### MARESFIELD TQ/4724

1. 1667, ROBERT BROOKS, loose under tower; 55.5 x 170.5 x 1-2.7cm.

One of the AETATIS SVÆ series; the date of death has been given instead of the age. The T has been omitted from 'aetatis'. Planklines.

In 1852 Hussey recorded three iron slabs in the chancel, for only one of which he gives a date.<sup>19</sup> The other two were presumably removed when the church was restored in 1879, being unattributed. They are buried in the churchyard about 2.1m south of the SW buttress of the tower

A mural monument in the chancel to John Baker (died 1688) records that he had 13 children of whom five are buried near their father, including John (2) and (3). These two are under iron slabs beneath the choir stalls.

A iron memorial in private hands commemorates the father of the John Bakers noted above (nos. 2 & 3): 1688, JOHN BAKER, 76 x 167cm

Pullein mentions a graveslab inscribed 'Here lieth the body of John Baker' used as a fireback in the mid-19th century at Hamsell, near Eridge station, home of another branch of the Baker family, and close to the furnace of that name where it may have been cast.<sup>22</sup> It is probable that this is a reference to the same graveslab, the poor quality of the inscription on the casting perhaps causing it to have been rejected for its intended purpose and relegated to use as a fireback instead.

Above the inscription, cast in high relief from an impressed large block (63cm wide x 58cm high, with curved top and lower corners cut off) is the full achievement of the Coopers' Company to which Thomas Sands was admitted in 1698: gyronny of eight gules and sable on a chevron between three annulets Or, a royne (a cooper's groove cutter) between two broad axes azure, a chief vert thereon three lilies argent. Crest - on a wreath Or and azure, a demi heathcock with body azure semee of annulets gold, the wings argent semee of annulets sable holding in the beak a lily argent slipped and leafed vert. Two supporters, on either side a camel gules semee of annulets and bridled Or; the Motto - Love as Brethren.

In his will he stated "I desire and order my Executor ... that the sume of Ten pounds be laid out and expended on one iron plate to be laid and affixed over my Grave".<sup>23</sup>

Some of the left hand side is illegible. Planklines. Peter Gower was tenant of Great Sprays Farm in the parish. The church lies 1km from the site of Ashburnham forge and 1km from the site of Ashburnham Furnace.

The slab was restored to the chancel in 1960 when the church was de-Victorianised. It had been taken up and left loose under the tower after the restoration of 1878-81.<sup>24</sup> When in 1960 the Victorian tiles were removed, 18cm 17th-century floor tiles were found (now repositioned in the south porch), and beneath them the remains of a coffin whose handles were dated by the British Museum to the time of Queen Anne. The slab is now hidden under a carpet.

The Peckham family commemorated in six of the seven slabs at Salehurst held the Iridge estate from the late-17th century. They were related by marriage to the Braban family of Wadhurst. All the Salehurst slabs were formerly in the nave but were removed at the 1861 restoration and placed at the west door under the tower. The graveslab of a member of the Braban family in Wadhurst church (No. 23) is stylistically very similar to Nos. 3 and 4 in Salehurst. Silvester and Eleanor Peckham were sisters.

William and Elizabeth Bishop's grandson William was the son of their only surviving son Richard who married Joane Warde of Bolney in 1639. Sarah was only two months old.

The largest slab in Sussex; virtually the same size as the contemporary slabs of 1745 and 1754 at Burrington, Herefordshire, (102 x 211cm). Well executed in good Roman capitals of two sizes, 6.5 and 4.8cm. Each line centred.

The pattern for this slab would have been prepared in 1734, following the death of Thomas Gott. Of the children of Martha and Peter Gott said to be surviving, all but Mary and Sarah had died before Elizabeth, whose death prompted the laying of the slab: Martha and Maximilian in 1735 and William in 1741.

From 1702 to 1795 the Gotts and their descendants owned the Gloucester Furnace at Lamberhurst, Conster or Beckley Furnace, Brede, and Crowham Forge, Westfield. Many of the names are the same as those on the graveslab of Martha Gott's father, Thomas Western, in Rivenhall, Essex.

The church was rebuilt in 1839, monuments from the previous building being retained. Prior to 1846 the church was a chapel of ease for Buxted.

There were many ironworks in this extensive parish. Over a quarter of the country's iron slabs of the pre-Industrial Revolution are at Wadhurst, 30 in the church, one in the porch and two in the churchyard.<sup>26</sup>

Same arrangement and form of shields as on the slab for Elizabeth Fowle (Frant no. 2), first wife of Nicholas Fowle's son, William: four corner shields with Fowle arms: a lion passant between three roses; in the centre two small shields each with square containing Fowle crest and (indistinct) initials beneath. The shields and crests are also seen on some firebacks.<sup>29</sup> In his will, having originally asked to be buried at Rotherfield, Nicholas Fowle directed his son to have him buried at Wadhurst.<sup>30</sup>

The incised initials belong to his daughter-in-law, Anne, the wife of his son, David.<sup>33</sup>

In her will of 1678 Jane Darby of Sedlescombe directed her executors to 'lay upon my grave an iron plate' next to that of her first husband, Thomas Baker, in Wadhurst church, a direction that clearly was not carried out.<sup>35</sup>

Dorothy Alchin, a spinster, (although she is referred to as Mrs in the Wadhurst register) was buried on 2 March 1688/9. Her will states that she was cousin of William Benge, father of Lucy Benge (*see* Laughton no. 1 which is of similar design).<sup>41</sup> A shorter slab (46 x 71.5cm) with the same date and initials (above the date only) and in the same style, but with no evidence of wear, is in private hands. The D is reversed, suggesting that the slab was rejected and a replacement casting made, with a second pair of initials, for laying in the church.<sup>42</sup>

Frances Colepepyr had previously married John Alcorne in 1667

Judith Legas was the wife of John Legas who worked the Gloucester Furnace and other ironworks. A marble monument on the west wall gives a detailed location of the slab and records that John "...by his Industry and Diligence in the Iron Works of this County Acquired a Handsome Fortune..."; John aspired to assume arms and the title Gentleman, although only his wife's (Saunders) arms were included on the marble monument.

31. 1771, JOHN WELLS LUCK and ANN LUCK *née* ALLEN, south porch; 91.5 x 185cm.

6.5cm letters on a plain borderless slab. A stone memorial tablet on the west wall of the porch gives further details and states that the bodies lie "under the iron plate". A tablet on the east wall records their grandson John, 1793, and his sons John, 1805, and George, 1807, all "Interr'd beneath the Iron plate"; the adjacent marble tablet incorporating two Harmer terracottas is to George's daughter, 1817, and wife, 1836.

A fireback of 1776 at Scotney Castle, Lamberhurst, bears lettering in the same style as on this graveslab.<sup>43</sup>

32. Date obscured, JOHN KEMP, *churchyard*, north-west of tower; 41cm wide, 2.5cm thick. Upright headslab with semi-circular head having a 0.5cm rim.

## WITHYHAM TQ/4935

Withyham church was destroyed by fire in 1663 when many monuments were lost; presumably it was at this time that three slabs, (Nos. 2, 3 and 4), found their way out of the church.

1. 1582/3, RICHARD GRAYE, chancel, under south stalls; 54cm wide.

Only the lower 17cm of the slab, which has a 1.6cm high rim, is exposed. The choir stalls are shaped to fit over it. The inscription is hidden but is recorded by R. W. Sackville-West in his *Historical Notices of the parish of Withyham* of 1857. Richard Graye was parson from 1576 to 1582.

Sutton states that 'replicas of the tomb' existed at Wolvesey Palace, Winchester, and '80 years ago' (i.e. in the 1820s) at Sompting.<sup>44</sup> The latter, a fireback, has now been donated to Withyham church, and its inscription reads,

The Baker family were landholders in Withyham in the reign of Henry VII. Robert, who was executor of Richard Graye's (no. 1) will, held Hamsell Furnace (TQ/5334). In the next century the Bakers were prosperous ironmasters at Mayfield.

3. 1593/4, LEWES JONES, Anne of Cleves House, Lewes (LH000.925); broken slab, 53.5cm wide, lower part broken (32cm remains).

Lewes Jones of Withyham, yeoman, made his will on 7 February 1593/4 and it was proved on 21 March (TNA PROB 11/83/258). In it he makes specific reference to Robert Sackville, although the Lord Buckhurst and his wife to which Jones's memorial refers was Robert's father Thomas.

4. 1610, WILLIAM ALFREY, inside loose against west wall; 39 x 121, uneven thickness of 1.6-3.2cm.

This slab was for long resting against the outside east wall of the church. It was there in 1902 and has subsequently been brought inside. Outside in the churchyard are a number of stone tombs with raised letters in recessed bands - as on the Wadhurst slabs - e.g. to Richard Maynard of Cozleigh (1612) east of the chancel on a low altar tomb.

## WEST SUSSEX

It may be significant that the only churches in West Sussex where there are iron graveslabs are in parishes formerly in East Sussex.

### EAST GRINSTEAD TQ/3938

1. 1570, ANNE BARCLEY, nave, in front of rood screen; 149 x 59.5cm.

Anne was the first wife of Henry Barclay who was later M.P. for East Grinstead. In 1875 the slab was found upside down in use as the scullery step in the adjacent Vicarage. It was returned to the church in 1881. The church had been destroyed by the collapse of the tower in 1785 and later rebuilt.

2. 1616, FRANCES HASELDEN *née* COVERT, nave south, in front of lectern; 134.5 x 46cm.

The lower corners have been cut off to make the slab fit a fireplace. The missing inscription and date have been cut into the surrounding pavement, ascertained from parish records. Haly is Hurley, 3.5km southwest of the church (TQ/3636).

3. 1714, THOMAS WICKERSHAM, mural, west wall of north aisle; 53.5 x 15.5cm 1.8cm thick at top and 2.2cm at base.

There are four slabs in the church. Hussey stated that the two Richard Infeld slabs were used as stepping stones to the tower.<sup>45</sup> In July 1907 the two slabs above were removed from the west and south doorways of the church 'for their preservation', suggesting that they may have been brought in from the churchyard; the design of the slabs, with longitudinal inscriptions, suggests they might have been intended for placing on altar tombs. In 1940, *Victoria County History, Sussex*, 9, mentions three slabs affixed to the wall in the vestry.

1. 1619, RICHARD INFELD, *mural* south wall; 153.5cm wide x 57cm, uneven thickness with corner measurements of 3.2 and 3.0cm top, 4.1 and 2.7cm bottom.

Richard was the son of Richard (d.1619, No.1) and died aged 25. He held the furnace at Mill Place as had his father. He married Katherine, one of the 12 children of Sir Edward Culpepper of Wakehurst in Ardingly, the next parish. She died in 1623 and was buried under stone at West Hoathly.

3. 1635, AGNES FAULCONER *née* INFELD, chancel, loose against north wall; 75 x 143 x 2.8cm.

Agnes was the sister of Richard Infield (d.1624, No.2) who married Katherine Culpepper, the daughter of Elizabeth (d.1633) who is buried at Ardingly.

4. c.1714, date and name indecipherable, chancel, north of altar; 53 x 151cm.

A plain borderless slab. Indecipherable *incised* inscription. It is comparable with the incised slabs at Hartfield (1702) and East Grinstead, (1714, No.3).

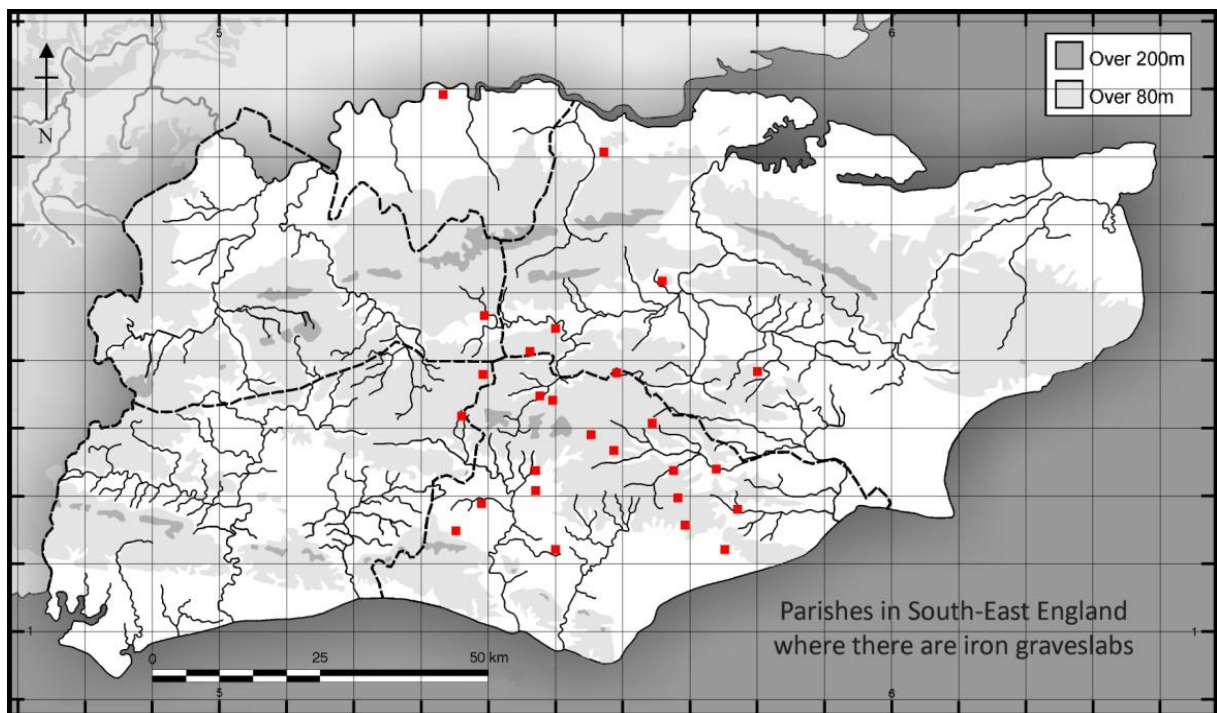

John Smith was baptised in November 1592 and was buried in July 1614, so the age given on the slab is incorrect. John Smith's father owned the nearby furnace and forge at Knutton, where it is probable the slab was cast. The slab originally lay in the church but was removed to the churchyard when the church was rebuilt in the 1720s. In 1874 it was sold for scrap, but restored to the churchyard in 1911.<sup>52</sup>

Both of the Beaumont slabs in Darton may have been commissioned by Thomas Beaumont, the brother of William, the last to be buried. There were financial connections between the Beaumonts and some of the iron-making business in south Yorkshire of the period. Although the inscriptions on the Beaumont slabs were recorded by R. H. Beaumont in 1805, and photographs exist from when the floorboards were raised, information about the exact details and spacing of parts of the inscriptions is not available.

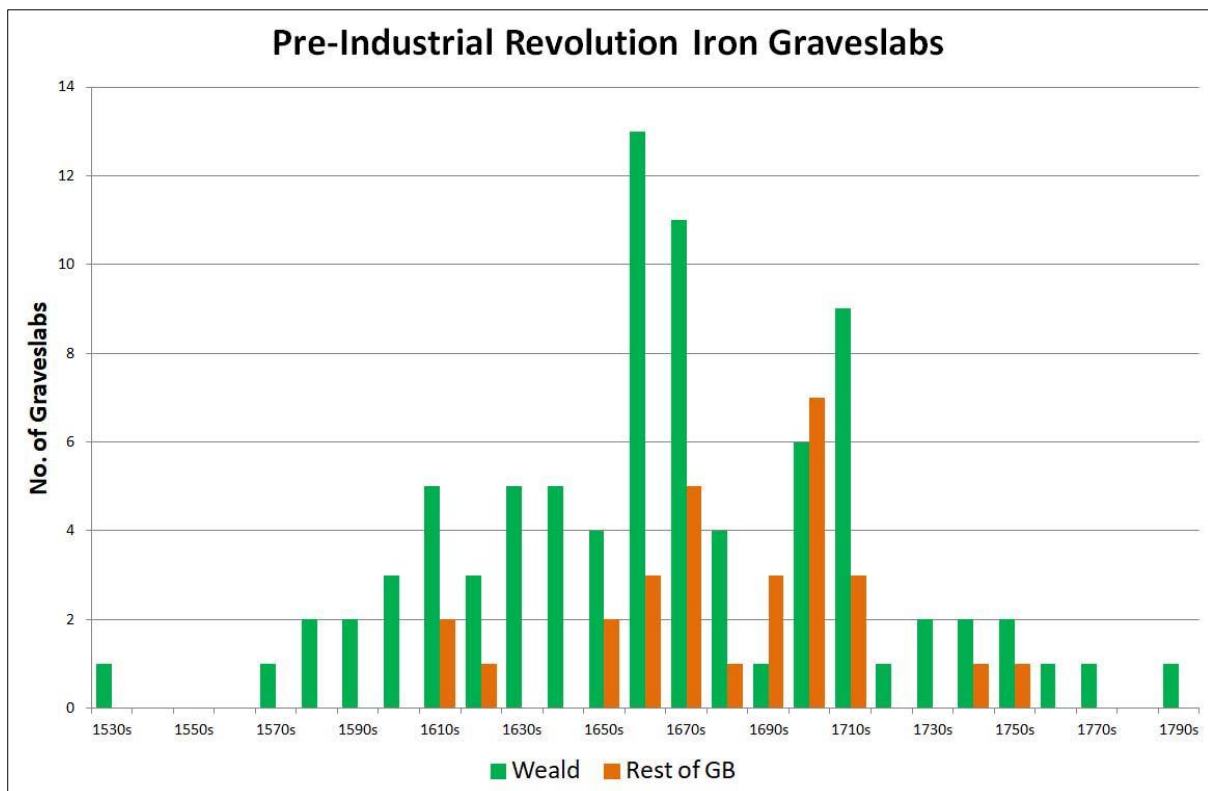
